Our academic summer curriculum consists of language, math, practical life, sensorial, art, geography and cultural subjects. We include daily Spanish, music, woodworking, gardening, hands on science projects, arts and crafts, cooking, water days, special visitors and much more.

Summer Tuition is due on June 28th for our Summer Program. There will be a late charge of \$30.00 if payment is not received by the 2nd of the month. You will be responsible for the Summer tuition if you cancel or your child does not attend the Session which you sign up for. Checks or credit cards returned by the bank are subject to a \$30.00 fee. We accept cash, check, credit cards and ACH bank account debit. We currently offer a 10% Sibling discount,

which is applied for complete sessions only. It does not apply for weekly sessions. Sibling discount is applied on the second, third, fourth child.

Child care is available in the Summer each day from 7:30am - 5:30pm at our Mt. Soledad campus only. You will be charged for the care you have signed up for per session even if your child is not present. These rates are calculated for our Summer Program. If you need drop-in care, please contact the school to check on space availability. Drop-in care will be billed at the daily rate or weekly rate depending on days and times used.

No deductions, make-ups or refunds can be made during our summer program for illness, holidays, vacations, withdrawal, late entrance, or other absences. If a child is withdrawn for any reason, refunds cannot be made unless said withdrawal is made at the specific request of the school. Your child is placed for the entire Summer Session(s) you signed up for. Changes or cancellations cannot be made after you turn in your Registration Form.

Parents will provide lunch and nutritious snacks. Children may not have sweets, candy, cookies at school for snack or lunch. We encourage that children eat healthy, nutritious foods only.

Montessori by the Sea accepts all children regardless of race, color or religion.

SUMMER REGISTRATION AND TUITION AGREEMENT - 2026

This Agreement is made and entered into between the Montessori by the Sea, hereinafter known as The School, and _____ (Father) and _____ (Mother) hereinafter known as The Parents. The School hereby accepts _____ (Child) for enrollment as a pupil for the Summer, 2026.

The School initially accepts all children on a trial basis; no notice is required if a child is released. At the request of The School, you will be released from your Tuition Agreement and any tuition paid and not used will be refunded.

The Parents agree to pay for the Summer Session(s) as follows:

1. **Summer Program Fee**, \$_____, due and payable by June 28, 2026.
2. **Extended Care Fee**, \$_____, due and payable by June 28, 2026.

There will be a late charge of \$30.00 if payment is not received by the 2nd. Checks or declined credit cards returned by the bank are subject to a \$30.00 fee. Tuition not received by the 10th of the month, will release the child from school. 10% Sibling discount is applied for complete sessions only. It does not apply for weekly sessions. Sibling discount is applied on the second, third, fourth child.

I understand and agree to notify the school in writing thirty (30) days prior to the early withdrawal. In the event of early withdrawal from Montessori by the Sea you are responsible to fulfill your financial obligation.

The School reserves the right to terminate this Registration and Enrollment Contract between The Parents and The School and release the child in case:

- (a) If there are disciplinary problems that cannot be resolved with the child or the parents (at The School's discretion);
- (b) If the program does not meet the parent's needs or expectations;
- (c) If the Director or Assistant Director considers that the school is not the right place for the child.

We, the undersigned, hereby give our consent to The School to call a physician for medical or surgical care for the pupil named herein, if an emergency arises whereby such service is indicated. In such event, it is understood that reasonable conscientious effort will be made promptly to notify The Parents.
